#### **VI. Processes for Campus Decision-Making**

1. Proactively monitor daily data metrics and consult with IDRT Chair, Cabinet, and direct consultation with County Departments of Public Health.
2. Consult with Chancellor's Office.
3. Consult with, communicate, and collaborate with multiple campus and community stakeholders to seek feedback, input and ideas.
4. Communicate to notify and disseminate decisions, action steps and COVID safety protocols.
5. Consult with local and regional K-12, community colleges, regional CSUs, elected officials.

#### **VII. Implementing Campus Safety Protocols, Policies, and Practices: Past, Current, Future**

2. Stan State Temporary Delay to Fall 2021 Repopulation: August 14, 2021
  - Process and online mechanisms for attestation and verification of full vaccination;
  - Process and supports for attestation of exemptions and required weekly testing;
  - Process for online verification of employee health status for supervisors using Daily Screening app;
  - Process and online mechanisms for student health status and access to campus classes, library, Student Center (e.g., using Daily Screening app, Green/Red screen app, faculty access to course roster widget);
  - Campus mandates for: indoor masking, social distancing, access to PPE, campus cleaning and disinfection protocols, campus ventilation, etc.);
  - Additional supports via hiring campus Stan State Take Care Team ambassadors and other key COVID-related staff positions.
3. As COVID conditions change and evolve, it is vital that the campus also update the campus' many safety protocols, policies and practices that includes consultation whenever possible.

#### **VII. Variables to Consider for Campus Action**

1. Emerging COVID variants nationally and in our counties;
2. Increased transmissibility of COVID variants in our counties, region;
3. Data showing greater incidence of serious illness and/or deaths in the counties and other educational institutions (K-12 USDs, community colleges, regional CSUs);
4. Campus COVID-related data metrics showing an upward trajectory of documented campus cases (per County Public Health Departments);
5. Degradation of robust testing capacity;
6. Significant, applicable action by the government or county public health.

#### **VIII. Future CCCT Meeting Frequency**

1. Due to the anticipated holiday COVID increase in cases in early January 2022, CCCT may meet more frequently in January, and will convene as COVID conditions evolve as necessary.
