Installment payment schedules are subject to an associated finance charge. The rates reflected above are based on a single housing payment. Students receiving financial aid are eligible for a deferred payment plan. Deferred payment plans are coordinated through the Housing Student Accounts Coordinator.

With the exception of Year-Round contracts December 23, 2009-January 3, 2010 are non-contract dates. Residents on contract for the academic year may not reside in their assigned living units during the winter holiday shutdown. Residents may leave their belongings during this time, but access to the facility will be restricted. Information on alternate living arrangements available for residents on these dates will be made available.

\$200 deposit is due at the time of application (\$40 non-refundable processing fee, \$40 activity fee refundable upon request, \$120 security deposit). This applies to all contract options except summer term which has a deposit of \$145 (\$25 non-refundable processing fee, \$120 security deposit).

ALL PAYMENTS ARE DUE ON THE 1ST OF THE MONTH. PAYMENTS NOT RECEIVED BY THE 10TH OF THE MONTH ARE CONSIDERED LATE.
