



**California State University, Stanislaus  
Annual Retiree Parking Permit Application**

Stanislaus State retirees who are retired from PERS and not currently enrolled or employed at Stanislaus State are eligible for an Annual Retiree Permit. The permits are \$24.00 and valid from Jan. 1 – Dec. 31. Eligibility status will be verified through Human Resources and Enrollment Services. If you participate in the Faculty Early Retirement Program (FERP) you will not be eligible for this reduced rate permit. Individuals receiving any compensation, stipend, honorarium, course credit or other forms of remuneration from Stanislaus State are not eligible for this permit.

This privilege is reserved for fully retired persons receiving no compensation from the University and is intended for your personal use only for occasional visits to campus. If you resume employment with the University, your retiree parking privileges will end.

Reduced rate permits are granted to the individual retiree and cannot be shared, transferred, and/or used by anyone other than the authorized permit holder. Any use of parking by anyone other than the permit holder will result in a parking fine, permanent revocation of the permit and permanent loss of the permit holder's privilege to receive special rate permits.

**To request an Annual Retiree Permit:** 1) Visit the University Police Department or find the document on our website under parking resources 2) Complete the application 3) Upon verification of eligibility, UPD will contact you via phone and ask you to come pay and pick up your permit.

Fees for permits purchased mid-year may be prorated for Retiree Permits at the University Police Department. No refunds are available.

Retiree parking permits entitle the authorized permit holder to park in all general parking spaces throughout campus. Use of these permits is not allowed in restricted areas such as faculty/staff, reserved, loading zones, and visitor spaces. Additional parking information is available online at:
