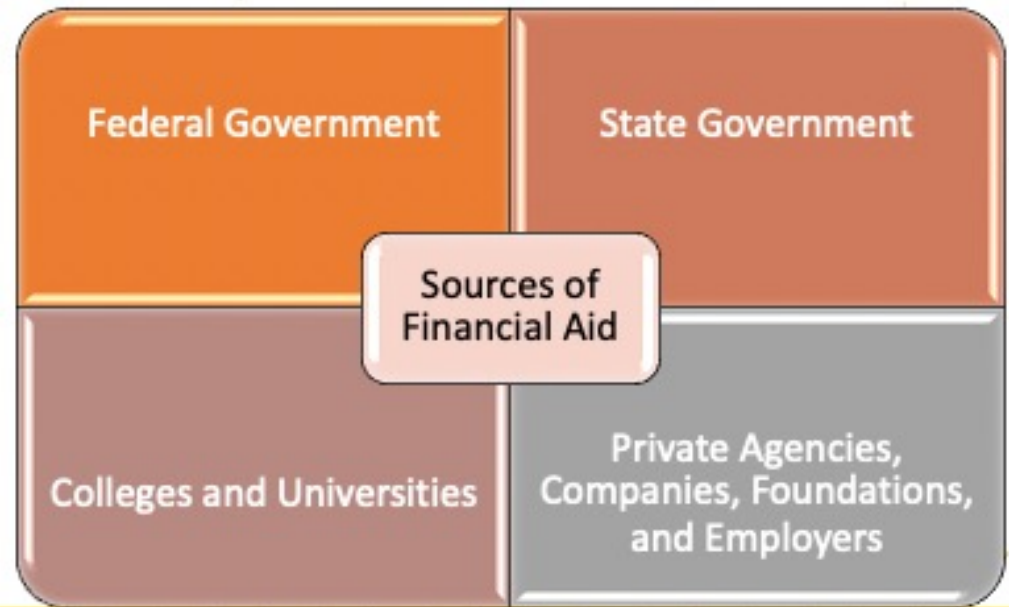

What is Financial Aid?

Financial aid is a resource provided to students and families to help pay for postsecondary educational expenses.

Where does it come from?



How do students apply for Financial Aid

- ▶ The Free Application for Federal Student Aid or the California Dream Act Application (FAFSA) (CADAA) for undocumented AB 540 students are required by all schools offering financial aid.
- ▶ Submit the FAFSA or CADAA each year that you would like to be reviewed for financial aid as early as October 1st, but no later than March 2nd.

 - ▶ FAFSA Degree: Teacher Credential
 - ▶ FAFSA Grade level: 5th year undergraduate-other

Federal Pell Grant & State University Grant (SUG)

- ▶ Grants awarded to eligible Undergraduate and Credential Program students who demonstration financial need.
 - ▶ Students can receive the Pell Grant for no more than 12 semesters (the equivalent of roughly six years).
 - ▶ State University Grant filing deadline requirement: The FAFSA or CADAA must be submitted no later than March 2nd for consideration.

Note: Undergraduate students may lose eligibility for State University Grant due to unit cap, however, units will reset to zero once students enters into a teacher credential program.

Teaching Cal Grant Renewal Program (G-44) form

- ▶ Undergraduate Cal Grant A and B recipients who plan to enroll in a teaching credential program (TCP), after they receive their bachelor's degree, may be eligible to renew their Cal Grant award for an additional year.
 - ▶ Students must be accepted and enrolled in a teaching preparation program within 15 months of receiving a Cal Grant payment.

What is the Teacher Education Assistance for College and Higher Education (TEACH) Grant?

- ▶ A federal program that provides grants of up to \$4,000 a year to students who are completing coursework needed to begin a career in teaching.
- ▶ As a condition for receiving the TEACH Grant, students must complete the TEACH Grant Counseling and sign an Agreement to Serve or Repay in which they agree to teach:
 1. In a high-need field;
 2. At an elementary school, secondary school, or educational service agency that serves students from low-income families;
 3. For at least four complete academic years within eight years after completing the course of study for which the student received the grant.

TEACH Grant Awards

- ▶ If a student is enrolled full-time, they can receive up to \$4,000 each year (\$2,000 per semester) in TEACH Grant funds, up to a maximum of:
 - ▶ \$16,000 for undergraduate and/or post baccalaureate programs combined*and*
 - ▶ \$8,000 for Master's program

Who can get a TEACH Grant?

▶ Students must:

- ▶ Have a valid FAFSA on file;
- ▶ Be enrolled in a TEACH Grant eligible program;
- ▶ Have and maintain a cumulative GPA of at least 3.25;
- ▶ Complete the TEACH Grant Counseling;
- ▶ Sign a TEACH Grant Agreement to Serve or Repay

What are the 2022-2023 high need fields?

- ▶ To fulfill the service obligation, students must teach full time for at least four years in one of the following fields:
 - Bilingual Education or English Language Acquisition,
 - Foreign Language,
 - Mathematics,
 - Reading Specialist,
 - Science (including, but not limited to, computer science),
 - and Special Education,
 - As well as - any other field that is included in the annual Teacher Shortage Area Nationwide Listing:
 - <https://tsa.ed.gov/>
 - Select the school year and state, then click submit.

After School Requirements

- ▶ Upon completing their program:
 - ▶ recipients will be asked to complete the TEACH Grant Exit Counseling
 - ▶ and be required to submit documentation to the TEACH Grant Servicer (Mohela Servicing Center) each year showing that they have completed a year of qualifying teaching service
- ▶ If recipients do not submit their documentation of teaching progress annually by Oct 31st each year, their grants may be converted to Direct Unsubsidized Loans that they must then repay with interest.

TEACH Grant Application Process

Golden State Teacher Grant Program (GSTG)

- ▶ Awards up to \$20,000 to students who are currently enrolled in a high-need teacher preparation program and commit to teach at a priority school in California for four years, within 8 years after completing their program.
- ▶ Eligibility requirements:
 - ▶ High-need fields are: Bilingual Education; Math; Science; Special Ed; Multiple Subject; and Transitional kindergarten
 - ▶ Priority Schools: School with 55% or more of its students being classified as: English learners; eligible for free or reduced-priced meals; or foster youth.

Middle Class Scholarships

- ▶ Is a program that provides undergraduate and teaching credential students who have income of up to \$201,000 a scholarship to help pay part of their tuition fee.
- ▶ Requirements:
 - ▶ Students must submit a FAFSA or CADAA no later than March 2nd to be considered.
 - ▶ Students may not be awarded other grants that pay more than 35% of their tuition.

Stan State On-Campus Scholarship Application Basics

- ▶ An online application to help our students search and apply for multiple scholarships using one application
- ▶ On-Campus Scholarships are available to both FAFSA and CADAA filers.
- ▶ Scholarship application period = November 1st - March 2nd each year.
 - ▶ Important: Both the scholarship application and a FAFSA or CADAA must be filed by March 2nd each year to be reviewed for a scholarship.

Federal Student Loans

- **Direct Subsidized and Unsubsidized Loan limits:**

Dependent

- No more than a total of \$23,000 in Subsidized
- No more than \$31,000 in Subsidized & Unsubsidized combined

Independent

- No more than a total of \$23,000 in Subsidized
- No more than \$57,500 in Subsidized & Unsubsidized combined

- **2022-2023 Federal Student Loan Interest rates:
4.99%**

Federal Loan Forgiveness Programs for Teachers

- **Public Service Loan Forgiveness (PSLF) Program**
 - Forgives the remaining balance on your Federal Direct Loans after 120 qualifying payments (estimated over 10 years)
 - You must have Direct Loans to qualify. If you have other types of loans, they must be consolidated in order to qualify.
 - Must work for a qualifying employer
- **Teacher Loan Forgiveness (TLF)**
 - Forgives up to \$17,500 of your Direct Loans after 5 complete and consecutive year of teaching at a qualifying school
 - Must teach full-time in Special Education, and secondary mathematics or science for max forgiveness of \$17,500
 - Other teachers may qualify for up to \$5,000

Research and Teaching Assistantships

- ▶ Research and teaching assistantships are available to students so that while pursuing an advanced degree, the University employs them to teach and/or conduct research.
 - ▶ Typically covers tuition plus stipend
 - ▶ Perform research as directed by faculty, teach, grade papers, hold office hours
 - ▶ Requires outstanding grades in the subject or may require teaching or tutoring experience
 - ▶ You are encouraged to network within your department and with professors for opportunities.

Financial Aid Enrollment Requirements for Teaching Credential Students

- ▶ Financial aid may only fund one teaching credential.
- ▶ Financial aid will not be granted to credential students who are enrolled in less than half time (6-units) status.
 - ▶ *exception of Golden State Teacher Grant.*
- ▶ Full-time status for credential students is 12+ units
- ▶ Grants will prorate based on units less than full-time.
- ▶ Some scholarships require full-time enrollment
- ▶ *Students should always check with the Financial Aid Office before dropping units to see how this will affect their financial aid award.*

We (TRRP/MSTI) can pay for your application processing fees up front.

IMPORTANT TIP

Depending on the student situation, reimbursements may vary (\$200 - \$600). If you decided to get reimbursement it may take an estimate time of 5 weeks!

\$2000 MSTI & TRRP Scholarships - Teacher Diversity Department

The Teacher Recruitment and Retention Program (TRRP) will award annual scholarships in the amount of \$2,000 for eligible students who intend to teach in a K -12 classroom setting in *Special Education & Math and Science teacher candidates*.

Application Deadline - Every January

- ▶ Requirements
 - ▶ Application - Fillable Application (PDF)
 - ▶ Minimum 2.75 GPA
 - ▶ At least 1 semester completed at Stanislaus State
 - ▶ Copy of unofficial transcripts from all institutions attended.
- ▶ Personal Statement (refer to the application for questions/topics).

Robert NOYCE Teacher Scholarship Program (Math and Science)

Scholarship Logistics

Junior level scholarship recipients who maintain eligibility and fulfill program requirements will be eligible to receive a \$10,000 scholarship annually for a maximum of 3 years, in exchange for a 2-year teaching service commitment in a high-need school for each \$10,000 award received.

Undergraduate Scholarship Recipients

Year	Scholarship Amount	Total Scholarship Amount	Teaching Commitment
Year 1 (Junior)	\$10,000	\$10,000	2 Years
Year 2 (Senior)	\$10,000	\$20,000	4 Years
Year 3 (Credential)	\$10,000	\$30,000	6 Years

Who Can Apply?

Junior level Math and Science Majors who want to become secondary teachers. Must have a 2.75 GPA or above.

Stan State Warrior TEACH! - Residency Pathway; Education Specialist Credential Program (ESCP)

Warriors TEACH! Pathway Benefits

- Immediately apply and practice what you learn in courses to your classroom teaching experience.
- Participate in co-teaching and experience the entire school year from start to finish.
- Program tuition is paid for summer, fall, winter, and spring semesters.
- Receive \$750 monthly living stipend (for 10 months).
- TPA/RICA and Induction costs are included for TUSD/CUSD teachers.
- Priority hiring consideration in the district where you complete your residency.
- Commit to teaching at least 4 years in the district where you complete your residency (if offered a position).
