SUMMARY OF REQUIRED CHANGES PER EO 1100

A GENERAL EDUCATION PROGRAM PATH TO 48 UNITS (OR 49 UNITS WITH AREA B LAB).

Revisions must be fully implemented by Fall 2019

“CSU campus GE requirements shall conform to the requirements established in this executive order and shall not exceed the requirements for 39 lower-division and 9 upper-division semester-units (or quarter-unit equivalent) in the defined GE Areas.” (EO 1100 - 2.2.1.)

DOUBLE COUNTING OF MAJOR AND GENERAL EDUCATION COURSES.

Revisions must be effective Fall 2018

Major courses and campus-wide required courses that are approved for GE credit shall also fulfill (double count for) the GE requirement.” (EO 1100 - 2.2.6.1.)

AREA D. SOCIAL, ECONOMIC, & POLITICAL INSTITUTIONS/HUMAN BEHAVIOR

Revisions must be effective Fall 2018

- 12 semester units, with 3 semester units taken at the upper-division.
- "At least two courses completed in 2 different disciplines, and 3 additional semester units at the upper-division.” (EO 1100 – 4)

AREA E. INDIVIDUAL RESOURCES FOR MODERN LIVING

Revisions must be effective Fall 2019

- “Area E requires 3 semester units (4 quarter units) of study, and campuses shall not exceed this unit requirement.” (EO 1100 – 4)

AREA F. UPPER-DIVISION GENERAL EDUCATION REQUIREMENTS

Revisions must be effective Fall 2019

AREA F. UPPER-DIVISION GENERAL EDUCATION REQUIREMENTS

Revisions must be effective Fall 2019

- "Nine upper-division semester units are required according to the following distribution:
- Area B (3 semester or 4 quarter units) Scientific Inquiry and Quantitative Reasoning
- Area C (3 semester or 4 quarter units) Arts and Humanities
- Area D (3 semester or 4 quarter units) Social Sciences

The 9 upper-division GE courses are designed to be taken after upper-division status (completion of 60 semester units or 90 quarter units) is attained. Students enrolling in upper-division GE courses shall have completed required lower-division GE courses in written communication, oral communication, critical thinking, and mathematics/quantitative reasoning. Campuses may require no more than 9 upper-division GE semester units (or the quarter equivalent)." (EO 1100 - 2.2.3.)

AREA G. MULTICULTURAL REQUIREMENT

Revisions must be effective Fall 2018

- If the campus chooses to maintain a Multicultural Requirement, all current area G courses must either double count with the GE areas, OR the Multicultural Requirement must be made a Graduation requirement outside of GE, similar to the Writing Proficiency Requirement.

GENERAL EDUCATION COURSE DELIVERY

"Provide sufficient numbers of Area A2 written communication and Area B4 mathematics/quantitative reasoning course sections to allow freshmen to complete these requirements in the first year of enrollment.

Courses approved for GE that have not been offered within a five-year period shall have GE status removed." (EO 1100 – 6.2.1.c.)

RE:	GE SUB Recommendations Regarding EO 1100

Throughout the Fall 2017 semester, individually and collectively the GE Subcommittee members have reviewed EO 1100. During this process, areas of benefit, areas of concern, and areas of confusion were noted. In order to bring our university's General Education program into compliance with EO 1100, the GE Subcommittee has the following two recommendations:

- Move the required government class PSCI 1201 from Area D1b out of Area D and instead have it stand alone as a university graduation requirement as is currently the case for the Writing Proficiency (WP) requirement. This would reduce the Lower Division General Education unit total in Area D from 12 to 9, which is the specified unit total in EO 1100.
- Rename Areas F1, F2, and F3 such that F1 becomes Upper Division (UD)-B, F2 becomes UD-C, and F3 becomes UD-D. This will correspond with how the General Education Areas are specified in EO 1100.

While these are the two main changes the GE Subcommittee is recommending, discussions have also centered on other aspects of EO 1100 and their impact on our General Education program such as the policy for double counting courses, Area G (multicultural requirement), and the labeling or names of the GE Areas. The GE Subcommittee will continue to keep the UEPC informed regarding our discussions of EO 1100 through our minutes and more formal notifications such as this memo if needed. Please let the GE Subcommittee know if there are specific tasks regarding EO 1100 that the UEPC would like for us to address.

CURRENT STANISLAUS STATE GENERAL EDUCATION (GE) REQUIREMENTS

TOTAL MINIMUM UNITS = 51

Lower-Division GE Requirement = 42 units minimum

Upper-Division GE Requirement = 9 units minimum

Multicultural GE Requirement = 3 units minimum (double counts for many courses)

AREA A. Communication Skills (9 units minimum)

Complete at least one course from each of the 3 groups.

A1. Oral Communication

A2. Written Communication

A3. Critical Thinking

AREA B. Natural Sciences and Mathematics (9 units minimum)

Complete at least one course from each of the 3 groups. Must include a laboratory course from either group 1 or 2.

B1. Physical Sciences

B2. Biological Sciences

B3. Mathematics

AREA C. Humanities (9 units minimum)

Include at least 3 units from group 1 and 3 units from group 2.

C1. Arts

C2. Literature/Philosophy

C3. Foreign Language

AREA D. Social, Economic, and Political Institutions and Human Behavior (12 units minimum)

Complete one course from D1a, the course from D1b, and a minimum of one course each from D2a and D2b.

D1a. United States History

D1b. United States Constitution and California State and local government

D2a. Human Institutions: Structures and Processes

D2b. Society and Culture

AREA E. Individual Resources for Modern Living (3 units minimum)

Include one course from each group. Only students under 25 years of age at time of entry to Stanislaus State must complete Area E2.

E1. [Personal Development]

E2. Physical Education Activities

AREA F. Upper-Division General Education Requirements (9 units minimum)

The distribution of the 9 units must include 3 units from each of the three following areas:

F1. Natural Science and Mathematics

F2. Humanities

F3. Social, Economic, and Political Institutions and Human Behavior

AREA G. Multicultural Requirement (3 units minimum) — *Many courses may fulfill both the multicultural and another GE area requirement. Some courses fulfill the multicultural requirement, another GE area, and the Graduation Writing Assessment Requirement (GWAR).*

DRAFT PROPOSED CHANGES TO THE GENERAL EDUCATION PROGRAM

Upper-Division General Education

Any upper-division course approved to satisfy a general education area will satisfy that area; this applies regardless of whether the course is within a student's major, minor, concentration, etc.

Area F

Upper division (UD) areas F1, F2, and F3 are renamed UD-B, UD-C, and UD-D respectively.

A course currently satisfying F1, F2, or F3 continues to satisfy the appropriate area in the renamed area UD-B, UD-C, or UD-D.

- F1, F2, F3 renamed UD-B, UD-C, and UD-D respectively.

DRAFT PROPOSED CHANGES TO THE GENERAL EDUCATION PROGRAM

Area D Social, Economic, and Political Institutions and Human Behavior

1. Area D.1.b is removed from the general education requirements.
2. Area D.1.a is renamed D.1 United States History, D.2.a is renamed D.2, and D.2.B is renamed D.3 with subarea titles remaining the same.

Note: PSC1201 (D.1.b) is already a graduation requirement and will lose its status as a GE course. Preferred by PSCI.

D. Social, Economic, and Political Institutions and Human Behavior

1. United States History
 - ~~b. One course covering United States Constitution and California State and local government:
PSCI 1201—American Government~~
2. Human Institutions: Structures and Processes.
3. Society and Culture.

DRAFT PROPOSED CHANGES TO THE GENERAL EDUCATION PROGRAM

Area E Individual Resources for Modern Living

Area E.2 is removed from the general education requirements. Area E.1 is renamed E.

Option A: Add a graduation requirement for a physical activity course requirement.

Note: Activity courses no longer in GE. Age exception no longer relevant. Preferred by KINS.

OR

Option B: Activity courses (currently KINS 1010—1999) continue as GE. Area E may not be satisfied with only activity courses.

Note: KINS will develop a 2-unit course in E linked to activity course(s).

- No longer in E: KINS 1010—1999 - Physical Education Activities
 - Add a physical activity graduation requirement.
-
- Remain in E: KINS 1010—1999 - Physical Education Activities
 - E may not be fully satisfied with activity courses.
 - KINS develops a 2-unit E course linked to activity course(s)

DRAFT PROPOSED CHANGES TO THE GENERAL EDUCATION PROGRAM

Area G

Area G is removed from the general education requirements; courses currently in Area G will maintain a “multicultural” designation.

Within a student’s general education program a minimum of three units must be in coursework designated as “multicultural,” courses addressing multicultural, ethnic studies, gender, or nonwestern cultures issues.

Note: Current Area G courses that do not also fulfill an area A-E requirement may apply for Area certification through an expedited normal process.

- G. Multicultural Requirement: Removed. Graduation requirement: at least 3 units taken in GE course designated “multicultural.”
