This form is used to assist the Commission on Accreditation in the evaluation of the program's compliance with the accreditation standard below:

4.0.3: The program uses Form AS 4(B) and/or Form AS 4(M) to report its most recent assessment outcomes for each program option to constituents and the public on its website and routinely up-dates (minimally every 2 years) its findings.

All programs accredited by the Council on Social Work Education's (CSWE) Commission on Accreditation (COA) are required to measure and report student learning outcomes. All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards (EPAS) and any additional competencies programs may choose to add. These holistic competencies reflect the dimensions (knowledge, values, skills, and cognitive & affective processes) of social work practice that all social workers are expected to master during their professional training.

Programs determine a percentage-based benchmark for each competency and determine an outcome-measure benchmark (minimum score) for each measure. The competency benchmark (which can differ for each competency) represents the minimum percent of students the program expects to have achieved the outcome measure benchmarks in both/all measures for each of the nine competencies. The program then determines the percentage of students that attained each outcome measure (e.g., minimum score or higher), and aggregates the percentages for both/all measures together to obtain the percentage of students demonstrating competence inclusive of two (2) or more measures. The result of aggregating both/all outcome measure percentages provides the percentage of students achieving the competency benchmark. An aggregated percentage at or above the competency benchmark is considered achievement of that competency. If the program has more than one program option, the program must report data for each program option, and also an aggregate of all program options combined to determine an overall percentage of students across all program options achieving the competency benchmark.

Per the requirement of CSWE COA's recognizing body, the Council on Higher Education Accreditation (CHEA), and accreditation standard 4.0.3, programs must post this form publicly on its website and routinely up-date (minimally every 2 years) its findings. Summary of the Program's Assessment Plan | Generalist Practice

All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards of the Council on Social Work Education. At the foundation level, 2 program assessment tools are used to examine student performance on the 9 required competencies and the associated 31 practice behaviors/performance indicators. These assessment tools include a Foundation Practicum Learning Plan & Evaluation and a Mid-Program Competency Assessment. The formula for holistically determining if the students meet the benchmark for each competency is as follows: 1) For assessment tool #1 (Foundation Practicum Learning Plan & Evaluation) the percentage of students meeting/exceeding expectation for each of the various practice behavior items associated with the competency are summed and averaged;

2) For assessment tool #2 (Mid-Program Competency Assessment) the percentage of students providing the correct answer for the each of the various practice behavior items associated with the competency are summed and averaged; and 3) The 2 scores from the measurement tools are summed and divided by 2 to produce the total percentage of students meeting the benchmark for each competency.

Summary of the Program's Assessment Plan | Specialized Practice

Students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards of the Council on Social Work Education and any additional competencies programs may choose to add, that reflect the area of specialized practice. At the specialized level, we utilize 2 program assessment strategies to examine student performance on the 9 competencies and 19 associated practice behaviors/performance indicators. The instruments include the: 1) Advanced Practicum Learning Plan & Evaluation (which serves as our real/simulated measure); and 2) A composite score produced by 3 Embedded Advanced Course Measures (Social Welfare Policy and Services for Social Justice II – SW 5002, Advanced Integrative Practice with Children, Adults, and Families – SW 5032, Advanced Integrative Practice with Communities and Organizations – SW 5034). The formula for determining if the students meet the benchmark for each competency is as follows: 1) For assessment tool #1 (Advanced Practicum Learning Plan & Evaluation) the percentage of students meeting/exceeding expectations for the various practice behavior items associated with the competency are summed and averaged; 2) For assessment tool number(s) 2-4 combined (all embedded measures) the percentage of student meeting/exceeding expectations for the various practice behavior items associated with the competency are summed and averaged; and 3) The 2 scores from the measurement tools (the Advanced Practicum Learning Plan & Evaluation and the combined Embedded Measures instruments related to the competency) are summed and divided by 2 to produce the percentage of students meeting the benchmark for each competency.
