WUE Guidelines

Conditions for enrollment:

- New freshman and new undergraduate transfer students who are enrolling for the first time may apply for WUE. Students must request the WUE tuition rate prior to enrolling in their first term. WUE students must declare their intent to maintain their legal domicile in their home WICHE state at the time of their application.
- Applicants must meet the eligibility index for nonresident applicants:

- WUE students are not eligible for California resident tuition. Students cannot apply time accrued while participating in the WUE program to establish California residency.
- Students may receive WUE tuition for four years or until the completion of the bachelor's degree, whichever comes first.

To maintain WUE status:

- Maintain full-time enrollment at 12 or more semester units each semester attended.
- Maintain a minimum 2.5 GPA each semester, including any transfer work, as calculated by CSU Stanislaus.

Example of WUE rate calculation for the 2011-12 academic year:

\$4,104	Total tuition fees
\$2,052	Additional 50% charged to WUE students
+\$ 555	total campus fees for resident and non-resident students
\$6,711	Total estimated tuition cost for WUE participants

State fees are subject to change. Students will be billed according to the fees in effect at the time of enrollment.
