What will I study?

Accounting is a systematic way of analyzing and describing the activities of business and other entities. Students learn to function as professionals as they develop the skill sets needed to work with people and information.

Our program emphasizes the importance of financial accounting, analytical skills, written and oral communication, and information systems. Interesting classes include: Cost Accounting, Auditing, and Income Taxation.

A degree in accounting is one of the most versatile degrees in business. Accounting is a part of all aspects of every business and helps inform the decisions made by employees, investors, and owners. The accountant is in a position to pursue a range of interesting and rewarding career paths in public accounting, private industry, consulting, and governmental careers. A large percentage of CEOs started their careers in accounting.

Students are encouraged to prepare for certification examinations such as the Certified Public Accountant (CPA), the Certified Management Accountant (CMA), and others. Organizations for accounting students enhance the coursework with networking and leadership opportunities.
