Requesting an IRS Tax Return Transcript – Tax Year 2013

The Tax Return Transcript is free of charge, and must be requested by the tax filer directly from the IRS. To request your transcript, follow the instructions below.

ONLINE REQUEST

- Now you have ability to print a processed Federal Tax Transcripts online, please visit <http://www.irs.gov/Individuals/Get-Transcript>
- Click on either “Get Transcript ONLINE” or “Get Transcript by MAIL”

- If you choose to “Get Transcript ONLINE”
 - ✓ You must create an account first, then, follow the steps to print the tax transcripts instantly.



- ✓ Once you are logged in, you will need to select the “Higher Education/Student Aid” button and the aid year tax transcripts you would like to print out.

- Tax filers must follow prompts to enter their Social Security Number, and the numbers in their street address. Be sure to use the address currently on file with the IRS (generally this will be the address that was listed on the latest tax return filed).
- Select “**OPTION 2**” to request an IRS Tax Return Transcript and the enter “**2013.**”
- If successfully validated, tax filers can expect to receive a paper IRS Tax Return Transcript at the address that was used in their telephone request – with 5 to 10 days from the time of the request.
