Any increase in the Tuition Fee, Non-Resident tuition and other campus fees will be due in addition to the currently deferred fees in equal installments as indicated above. Course fees, late fees if any, must be paid with the first payment.

I understand if my payment is dishonored by the bank I am subject to a \$25.00 (\$35 for second occurrence) fee and hold placed on my records. I further understand that if my installment payments are not received by the due date a \$25.00 late charge will be assessed and a hold will be placed on my records until payment is received. I understand that I will be unable to register for a future term, receive transcripts or any campus service until all fees and penalties are paid in full. I further agree to pay the total of this contract whether or not academic credit is received. If I withdraw from the University on or after the first day of class, I understand that I am responsible for a prorated amount of registration fees. If I add classes after enrolling in the IPP I will be responsible to pay the additional fees by the fee payment deadline in the schedule of classes.

I understand that failure to pay the amount due may result in referral of the debt to an outside collection agency and/or credit reporting agency; offset against amounts due from the State of California; legal action. I agree to pay all cost of collection, including attorney fees and court cost.
