- Send completed application with a copy of your current RN license, a résumé with cover letter indicating professional goals, statistical data form, and two professional letters of reference.
- The School of Nursing will notify candidates selected for admission.
- A new student orientation will be scheduled the week prior to the start of the first semester.

Admission Requirements for the M.S. in Nursing

- Bachelor of Science Degree in Nursing from an accredited institution.
- Minimum of a 3.0 cumulative grade point average (on a 4.0 scale) in the last 60 units of undergraduate coursework. (Conditional admission is available for GPAs between 2.5 -3.0).
- Current, active California R.N. license.
- One-year full time nursing experience post initial R.N. licensure, preferred.
- Satisfactory completion of an undergraduate statistics course. Must be taken before the second semester of the program with a minimum grade of C.
- International Students: Proficiency in spoken and written English with the following minimum TOEFL scores: 550 for the paper-based examination, 80 on Internet-based examination.

Admission Requirements for the BRIDGE M.S. in Nursing

- Non-Nursing Bachelor's Degree and an Associate Nurse (ADN) from accredited institutions with a current California R.N. license.
- All requirements listed above and students must pass the **WPST** prior to being admitted, visit www.csustan.edu/testing/ for dates and times.
- Completion of 4 BRIDGE courses (NURS4000, NURS4400, NURS4410, NURS3310) prior to progressing into the graduate culminating experience. Availability of BRIDGE courses would correspond with the current RN-BSN roadmap, visit www.csustan.edu/Nursing for program roadmaps.
