### Committee Preference Forms

This year, we received **147** Committee Preference Forms, a decrease from **196**. Thank you to each faculty member who submitted these forms as they make the work of the Committee easier. Committee on Committees struggled to assemble a Spring ballot that included multiple names for each position, and this task has repeatedly been a struggle in recent years. In some cases, the Committee had difficulty in securing even one individual to run for a given position. The difficulty in getting volunteers may be a result of faculty concerns regarding workload and available time to commit to committees, and also a result of the simple increase in number of committees. We believe that finding faculty willing and able to serve on committees will continue to be a challenge but we are hopeful for change in the future.
