POSITION TITLE & DESCRIPTION: TENURE-TRACK ASSISTANT

PROFESSOR/COORDINATOR OF MUSIC EDUCATION: The Department of Music invites applications for a full-time, tenure-track appointment at the rank of Assistant Professor. The person appointed to this position will coordinate and instruct in the Music Education curriculum, including supervision of student teachers, and will also assist the Director of Instrumental Studies in recruitment and program administration. Other teaching areas will be assigned dependent upon the qualifications of the candidate and department needs. Effective teaching, scholarly productivity/creative activity and service to the University are required for retention, promotion, and tenure. This is an academic year appointment. Opportunities may exist for additional Summer Session assignment.

MINIMUM QUALIFICATIONS:

Outstanding instrumental music educator with minimum three years' demonstrated success in public school teaching and requisite administrative and recruitment skills for the position. Candidates should be well versed in current methodologies and teaching practices germane to the position. Doctorate in appropriate field required. Candidates with ABD status will be considered beyond the initial round of review only if the dissertation advisor confirms the candidate is on track to complete all requirements for the doctorate by August 17, 2016.

PREFERRED QUALIFICATIONS:

A candidate's consideration will be enhanced by demonstrating at least five years of successful teaching in a public school environment, along with experience in instrumental conducting and/or teaching in an applied instrumental area. Knowledge of and experience with innovative, contemporary methods of music education are highly desirable.

HOW TO APPLY & DEADLINE:

A complete application is required and must include: an application letter, specifically addressing the position description and qualifications; unofficial photocopies of graduate transcripts; a professional CV; and contact information for at least three professional references. Video files of conducting and/or performance and copies of recent programs will be requested if needed. Official transcripts will be required at the time of hire. ***Online application submissions are preferred. CRIMINAL BACKGROUND CLEARANCE NOTICE

The university requires a criminal background check to be completed for all of its new employees, current employees seeking promotional or transfer opportunities, and current employees assigned new duties. Necessary background investigations will be conducted, as required, depending upon the job requirements of position.
