- POSITION:** **POSITION TITLE & DESCRIPTION: ASSISTANT PROFESSOR OF VOICE AND MOVEMENT:** The Department of Theatre invites applications for a full-time, tenure-track appointment at the rank of Assistant Professor. The person appointed to this position will teach in the following curricular areas: Voice; Movement; Acting in the Classics; and other areas of specific interest/training such as Acting for the Camera or Stage Combat. Additional duties will include: Teaching Acting for Non-Majors; and directing at least one production within the Department's five-show season. Other responsibilities will likely include: participation on university committees; curriculum development; student advising; student recruitment; and active participation in production and faculty meetings. The department seeks a dynamic and innovative teacher who is committed to service and engaged in active performance or creative/research projects at the local, regional, and national levels. Effective teaching, scholarly productivity, creative activity and service to the University are required for retention, promotion, and tenure. This position is contingent upon the availability of authorized funding.
- MINIMUM QUALIFICATIONS:** MFA in Performance is required. Other minimum qualifications include:
- Combined equivalent of two years full-time teaching at the college or university level
 - Strong foundation in process-oriented, actor training
 - Significant professional experience
 - Demonstration of effective teaching and mentorship
- PREFERRED QUALIFICATIONS:** A potential candidate's consideration will be enhanced by providing evidence of:
- Professional affiliation in one or more of the following: VASTA, AEA or SAG/AFTRA
 - The ability to teach anatomy and physiology of the voice, IPA, classical text and verse and physicalization of character
 - Certification/extensive training in an established movement system (e.g. Viewpoints, Laban/Bartenieff, LeCoq, Alexander, Suzuki, Stage Combat) or established vocal techniques (e.g., Linklater and Skinner)
- HOW TO APPLY & DEADLINE:** A complete application is required and must include: an application letter specifically addressing the position description and qualifications; unofficial photocopies of graduate transcripts; a professional résumé, including the names, addresses, and telephone numbers of three references. Official transcripts will be required at the time of hire. Screening of completed application files will begin on March 1, 2016. Electronic submissions preferred. The position will remain open until filled. This appointment begins on August 18, 2016.

CRIMINAL BACKGROUND CLEARANCE NOTICE

The university requires a criminal background check to be completed for all of its new employees, current employees seeking promotional or transfer opportunities, and current employees assigned new duties.
