

## Fall 2021 Reopening Survey Report: Graduate/Postbacc Respondents

The Fall 2021 Reopening Survey opened on March 10, 2021 and closed on March 19, 2021. The survey population included all state- and self- supported students currently enrolled in Spring 2021 and not currently enrolled but active/eligible to enroll in Fall 2021.

Survey responses in this report are filtered for graduate and postbaccalaureate students (i.e., credential, certificate, master's, doctoral, and all other postbaccalaureate students, including students seeking a second bachelor's degree). Online MBA respondents are excluded from the survey results.

A total of 1,738 graduate and postbaccalaureate students were successfully emailed the survey; 529 students completed or partially completed the survey, for an adjusted response rate of 30.4%.

The Reopening Survey was adapted from Fresno State's reopening survey and was used with permission.

- 54.7% are extremely or moderately uncomfortable with face-to-face instruction in the red tier; 28.4% are extremely or moderately comfortable with face-to-face instruction in the red tier
- 62.8% are extremely or moderately uncomfortable with attending/participating in campus events in the red tier; 18.3% are extremely or moderately comfortable with attending/participating in campus events in the red tier

- About 46% are extremely or moderately uncomfortable with face-to-face instruction in the orange tier; 33.9% are extremely or moderately comfortable with face-to-face instruction in the orange tier
- 51.8% are extremely or moderately uncomfortable with attending/participating in campus events in the orange tier; 25.3% are extremely or moderately comfortable with attending/participating in campus events in the orange tier

### Highlights

- 27.9% are extremely or moderately uncomfortable with face-to-face instruction in the yellow tier; 45.7% are extremely or moderately comfortable with face-to-face instruction in the yellow tier
- 33.1% are extremely or moderately uncomfortable with attending/participating in campus events in the yellow tier; 36.1% are extremely or moderately comfortable with attending/participating in campus events in the yellow tier

- Of those that responded, 50.8% preferred virtual/online courses and 23.5% preferred face-to-face instruction for fall 2021.

The only thing that would discourage my return, Fall 2021, is if instruction remains online. I do not feel I learn as much online as I do when I am engaged in face-to-face learning. I would prefer waiting, rather than paying for less than I deserve.

I work in a COVID-19 unit so I would feel uncomfortable risking other students in my cohort

Class size & vaccine distribution are two major factors in my decision making.

Lack of enforcement of masks and social distancing

People not being vaccinated

My son is in elementary school, I drop him off and pick him up. After school programs will not be opening soon. If my son has somewhere to go after school I would return back to campus.

I personally do not want to return until the pandemic is in good control. I am not only a student of CSU Stanislaus, but I am also a staff member. Safety is extremely important to me, and I think if the university move to F2F, we are moving too fast. Its okay to start F2F after other universities....

My spouse is also a Stan State student, and she has a terminal lung disease. I have been discriminated against because of my stringent guidelines for Covid-19. I am afraid of being stared at and mocked for wearing a mask/caring about COVID. I also fear that so many students are ill-informed and reluctant to get vaccinate against COVID. I want to see Stanislaus enforce strict protocols.

**Highlights**

- 59.3% of respondents would probably or definitely return to campus if the vaccination rate is above average
- 58% of respondents would probably or definitely return to campus if social distancing, hand-washing, face-covering guidelines, and temperature checks are enforced
