Information & Instructions for Supervisors and Injured Employees

Please post in a public area and provide to those responsible for reporting work related illnesses or injuries. Information and forms listed below are also available online at www.csustan.edu/hr on the Employee Benefits page.

Within 24 hours after an injury / Illness occurs:

- Supervisor to complete the electronic [SUPERVISOR'S REPORT OF EMPLOYEE INJURY](#)
- Supervisor to complete the employer section of [EMPLOYEE WORKERS' COMPENSATION CLAIM FORM \(DWC-1\)](#) and provide the injured employee a copy of the DWC1 along with the Notice of Potential Eligibility
- Return both completed forms to Human Resources. Please FAX: (209) 664-7182; mail interoffice in sealed confidential envelope or hand deliver to MSR320.
