This action is permitted under section 668.165 of the CA Administrative Code as detailed in sections I.I and I.J. of the 2019-2020 Housing License Agreement.

**Section I.I.** *A Licensee may defer payment of license fees if they demonstrate that they will receive federal, state or other financial aid and that such aid will be distributed to the licensee after the beginning of the fee period. Approval of deferment requests shall be subject to verification of pending aid by the University Financial Aid Office.*

The deposit will be paid from financial aid funds released during your first term of your contractual period, unless otherwise specified (e.g. Academic Contract: Fall 2019, Spring Contract: Spring 2020). The University will deduct first tuition fees, then meal and housing fees from each semester’s financial aid disbursement. If all financial aid for a particular semester has been disbursed and you still have an outstanding housing balance, you must pay the outstanding balance by the end of that semester.

**Cancellation of your Housing Application:** *If you complete and submit this form and subsequently cancel or have your application administratively cancelled you will be charged the \$40 non-refundable application processing fee in addition to any appropriate charges as permitted under sections I.D., VI, and VII of the 2019-2020 Housing License Agreement.*
